

**PERSONAL GUARANTY**

Whereas, Two Busy Guys, LLC dba "AG Distributors", an Idaho Limited Liability Company (the "Seller"), is willing to sell products to the Buyer and extend credit to the Buyer provided that the Guarantor guarantees the payment of the account balance in accordance with the terms extended by the seller; and,

Whereas, the Guarantor desires to have the Seller extend credit to the Buyer;

Now, therefore, in consideration of the Seller extending credit to the Buyer from time to time, the Guarantor does hereby unconditionally guaranty the prompt payment of all monies owed to the Seller by the Buyer in accordance with the terms extended by the Seller as the same may be modified from time to time. Such guaranty is not conditioned upon the pursuit of any remedies against the Buyer, or any guarantor, surety, or collateral, by the Seller.

For the same consideration, the Guarantor further agrees that without in any way releasing the Guarantor or reducing any liability on this guaranty, the Seller may, from time to time, at its option and without notice to the Guarantor, extend the time or change the terms or manner of payment, or receive, renew, or extend notes evidencing said indebtedness, either before or after maturity; accept partial payment or payments or grant extensions or forbearances; and otherwise deal with the Buyer and/or any guarantor, surety, or collateral. The Guarantor hereby waives (I) notice of acceptance of this guaranty; notice of the creation of any indebtedness of the Buyer to the Seller; notice of renewals, changes, or extensions of credit; and notice of the respective maturities of any notes or renewals thereof from time to time; and (II) presentment for payment, notice of non-payment, protest, and notice of protest.

No act or omission at any time on the part of the Seller shall in any way whatsoever affect or impair the guaranty. This guaranty shall extend to and inure to the benefit of any transferee, endorsee, or assignee of any indebtedness guaranteed hereunder, and shall be binding upon the Guarantor and his or her heirs, personal representatives, successors, and assigns. This Guaranty shall continue until cancelled by the Guarantor in writing, and signed by the Guarantor and delivered to the Seller at it's principle place of business, 17 North Phillippi Street, Boise, Idaho 83706. Such cancellation shall be effective only as to credit, if any, extended to the Buyer following proper cancellation and Guarantor's obligations hereunder shall continue with respect to all credit extended to the Buyer prior to cancellation hereof.
